

Volunteer Petition Circulator Checklist:

PHASE 1: BEFORE COLLECTING SIGNATURES

DO Fill in 5 Boxes

- 1** Check the **VOLUNTEER BOX** in the upper right corner. **FRONT**
- 2** Fill in the **COUNTY** in which you plan to circulate and collect **ALL** your signatures. **FRONT**
- 3** Fill in the **COUNTY AGAIN** in which you plan to circulate and collect **ALL** your signatures. **FRONT**
- 4** Fill in your **FULL NAME** **BACK**
- 5** Fill in your **COUNTY** of residence **BACK**

STOP! DO NOT ...

- DO NOT print, scan or copy the petition sheets.** Call (480) 382-8156 to get additional sheets.
- DO NOT remove the attached pages** of the initiative language from the petition **OR EVER** remove the staple.

PHASE 2: COLLECTING SIGNATURES

5 DOs of Collecting Signatures

- 1** **DO** Ask each person if they are a **REGISTERED ARIZONA VOTER** prior to signing.
- 2** **DO** ensure they use **BLUE** or **BLACK PEN** to fill out the signature line
- 3** **DO** Witness **EVERY SIGNATURE**
- 4** **DO** ensure the voter completes **THE ENTIRE LINE THEMSELVES.** **FRONT**
- 5** **DO** ask signers to put the complete date, **FOR EXAMPLE 9/28/21, NOT 9/28.** **FRONT**

STOP! DO NOT ...

- DO NOT leave your petition unattended**
 - DO NOT fill out the signature, name, address or date for the voter** or allow anyone else (such as a spouse) to do so. **For example:**

- DO NOT allow signers to use "ditto marks"**
 - DO NOT collect signatures of voters who reside outside of the county**


PHASE 3: TURNING IN PETITIONS

2 DOs of Petition Turn In

- 1** **DO** Locate a **DROP OFF LOCATION** on **AZVOTERID.COM.**
(A Notary Public will be available at each of our Drop Off Locations)
- 2** **DO** Fill out the rest of the sheet **WITH THE NOTARY** upon petition drop off. **BACK**

STOP! DO NOT ...

- DO NOT remove the attached pages** of the initiative language from the petition **OR EVER** remove the staple.
- DO NOT collect any additional signatures** after the date of notarization.
- DO NOT sign the back of the petition** without the notary public as witness.



Warning: It is a class 1 misdemeanor for any person to knowingly sign an initiative or referendum petition with a name other than his own, except in a circumstance where he signs for a person, in the presence of and at the specific request of such person, who is incapable of signing his own name because of physical infirmity, or to knowingly sign the name more than once for the same measure, or to knowingly sign such petition when he is not a qualified elector.

Instructions for Circulators

- All circulators shall sign the Affidavit of Circulator.
- All non-resident circulators, whether paid or volunteer, must register with the Secretary of State's office before circulating petitions. Circulators who are Arizona residents must register with the Secretary of State's office before circulating petitions if they are both (i) paid, and (ii) circulating for a statewide initiative or referendum. Registered circulators are strongly encouraged to print their Circulator ID number in the space provided on the front and back side of each petition sheet.
- Circulators are not required to be a resident of the state but otherwise must be qualified to vote in this state.
- Circulators shall include their actual residence address or, if no street address, a description of their residence location.

Affidavit of Circulator
